FICTITIOUS BUSINESS NAME STATEMENT  
**PUBLICATION REQUIREMENTS**

**The California Business and Professions Code requires that Fictitious Business Name Statements be published as follows:**

- **Statements must be published once a week, for 4 consecutive weeks** in a newspaper of general circulation in the county where the fictitious business name was filed.
- **Publication must begin within 30 days** of the date of filing the Statement.
- **If registrant has no place of business in this State**, the notice must be published in a newspaper of general circulation in Sacramento County.
- **An affidavit of publication must be filed with the Business License Section within 30 days of completion of the publication** (the affidavit is normally sent to our office by the newspaper--you may want to confirm that the paper you choose provides this service).
- **If you are renewing a previous statement and there are no changes, the Statement does not need to be published.**
- **Statements of Abandonment must be published** in the same manner as above.
- **Statements of Withdrawal from Partnerships must be published** in the same manner as above unless a notice of the dissolution of the partnership has been published pursuant to Section 15035.5 of the Corporations Code.
